Purpose of Personal Data Processing Your **visual personal data is processed via security cameras** for the purposes of ensuring the security of our Company's buildings and areas of operation, preventing and detecting criminal acts such as theft, fulfilling occupational health and safety obligations, using as evidence in possible incidents, tracking visitor entry-exit, and protecting our Company's legitimate interests.

Categories of Processed Personal Data Through security cameras, visual recordings are taken at our building's entrance doors, exterior facade, sales areas, warehouses, and other common areas. In this context, **identity (face) and image recordings are processed as personal data.**

Method of Personal Data Collection and Legal Basis Your personal data is collected in a physical environment, entirely by **automated means, through security cameras.**

This personal data processing activity is based on the legal grounds specified in Article 5, paragraph 2 of the KVKK:

- **It is mandatory to process data for our Company's legitimate interest.** This legitimate interest consists of ensuring the physical security of our Company, preventing theft and other criminal incidents, ensuring property and life safety, and maintaining operational efficiency.
- Furthermore, it is processed based on the legal ground that **data processing is mandatory for the establishment, exercise, or protection of a right in potential legal disputes.** This includes the need to present evidence in judicial and administrative processes.
- **Fulfillment of Legal Obligation:** Your personal data is also processed for the purpose of fulfilling our legal obligations as required by relevant legislation (if any).

To Whom and For What Purpose Can Processed Personal Data Be Transferred

- Your collected personal data may be shared with **authorized law enforcement agencies (Police, Gendarmerie), judicial authorities (courts, public prosecutors' offices), and relevant public institutions and organizations** for the purposes of resolving legal disputes, fulfilling legal obligations, ensuring physical security, and conducting criminal investigations, in line with the processing purposes stated above.
- Relevant departments within the Company (**e.g., security, legal, human resources, etc.**) may also share data for these purposes.

Your requests within the scope of Article 11 of the Law, which regulates "Rights of the Data Subject," can be made by submitting a petition prepared in accordance with the Communiqué on the Procedures and Principles for Application to the Data Controller (Official Gazette: 10.03.2018/30356) or by sending the **"Personal Data Owner Application Form"** obtainable from www.sultanahmetkoftesi.com to SULTANAHMET KÖFTECİSİ's e-mail, postal address, or physical address.
