#### **For the Purpose of Evaluating Your Franchise Application and Managing the Processes:**

- **Purpose:** To meticulously review your application, evaluate your suitability against our Company's franchise criteria and financial adequacy, analyze your work experience and business plans, conduct necessary feasibility studies, and make decisions regarding your application.
- **Legal Basis:**
  - **It is necessary to process personal data of the parties to a contract, provided that it is directly related to the establishment or performance of the contract** (preparation stages before the potential franchise agreement is established).
  - **It is mandatory to process data for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject** (evaluating the applicant's suitability and potential risks, protecting our commercial interests).

#### **For the Purpose of Carrying out Communication Activities:**

- **Processed Personal Data:** Your contact information (phone number, e-mail address, home address).
- **Purpose:** To contact you regarding your franchise application, respond to your questions, and provide updates on the status of your application.
- **Legal Basis:**
  - **It is necessary to process personal data of the parties to a contract, provided that it is directly related to the establishment or performance of the contract** (communication regarding the application process).

### **For the Purpose of Fulfilling Legal Obligations:**

- **Purpose:** To fully comply with the legal obligations arising from the regulations to which our Company is subject.

- **Business Partners and Service Providers:** Your data may be transferred, solely for specific purposes and proportionately, to third-party natural or legal persons from whom our Company receives services for its operations, such as information technology (IT) service providers, accounting services, legal consultancy, audit firms, or credit risk assessment organizations. These individuals may act as data processors based on the authority given by the data controller, or they may also be data controllers for their own purposes in certain situations.
- **Legally Authorized Public Institutions and Organizations:** In cases required by relevant legislation and upon request by authorized authorities, your data may be transferred to relevant public institutions and organizations (e.g., tax offices, judicial authorities, Trade Registry Directorates) to fulfill our legal obligations.

Your personal data is collected by **filling out this Franchise Application Form electronically, either entirely by automated means or by non-automated means as part of a data recording system.**
